EASEMENT

THE OMAHA NATIONAL BANK, a national banking association, party of the first part, does hereby grant and convey unto SANITARY AND IMPROVEMENT DISTRICT NO. 2, Knox County, Nebraska, and to all real property owners within the boundaries of Sanitary and Improvement District No. 2, parties of the second part, a permanent non-exclusive easement for purposes of ingress and egress to the Devils Nest Development area. Said easement shall begin at a point described as follows:
