NOTICE TO VOTERS REGISTERED AS NONPARTISAN

Pursuant to Nebraska Revised Statute §32-912, registered voters who are not affiliated with a political party and who desire to vote in the Primary Election to be held on May 14, 2024 for the offices of United States Senator and United States House of Representative may request a partisan primary ballot for any one of the State recognized political parties.

In addition, the Nebraska Democratic Party, the Nebraska Libertarian Party, and the Nebraska Legal Marijuana NOW Party have opened their ballots to Nonpartisan voters for the 2024 Primary Election, which allows Nonpartisan voters to request a **Nonpartisan Partisan** ballot from one of these parties with ALL of that party's federal and state races.

If you choose to request a **Nonpartisan Partisan** ballot for the 2024 Primary Election, please complete the form below and mail it to the Knox County Clerk, PO Box 166, Center NE 68724, **OR** scan and email it to clerk@knoxcountyne.gov, **OR** place it in the drop box located in the foyer of the Courthouse east entrance. The form must be received **BY MAY 3, 2024** to ensure mail delivery to you of the Nonpartisan Partisan ballot of your choice.

You may also bring the below form **AND YOUR NONPARTISAN BALLOT** to the Knox County Clerk's Office and vote the Nonpartisan Partisan ballot you choose in person at my office until May 14, 2024, at 8:00 p.m.

The party ballot you choose is in effect for this election only. No registered voter shall receive more than one such partisan ballot. Knox County is a By Mail Election County and there are no polling places.
