

PROCEEDINGS OF THE KNOX COUNTY BOARD OF SUPERVISORS

A regular meeting of the Knox County Board of Supervisors was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, September 4, 2024 at 9:30 a.m. Present were Supervisors Martin J. O'Connor District #1, Patrick J. Liska District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, Danny R. Schlote District #6, and James J. Borgmann District #7. Absent was none. Chairman Sokol, Jr. presiding.

Supr. Mackeprang led the Board in the Pledge of Allegiance.

Chairman Sokol, Jr. announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Bloomfield Monitor newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

Chairman Sokol, Jr. approved the minutes of the August 21, 2024 meeting as read.

The public comment session was held from 9:44 a.m. until 10:09 a.m. Clint Miller, James Mlady, Matt Frank, and Roger Tacey gave public comments regarding the proposed solar project west of Verdigre.

Motion by Supr. Schlote, seconded by Supr. Liska that all claims, audited and approved for payment by the Claims Committee, be allowed subject to delinquent personal taxes. By roll call vote. Ayes all Districts. Nays none. Motion carried. Claims totaling \$654,717.96 are listed at the end of these proceedings.

Chairman Sokol, Jr. moves the Board recess for Board of Equalization at 10:09 a.m.

The Knox County Board of Supervisors reconvened at 10:17 a.m. with all members present.

Hwy. Supt. Barta met with the Board on the following: 1.) Bridge Crew update; 2.) Oil Crew update; 3.) Update on the Shaw Bridge and Verdigre North Bridge projects; 4.) Update on FEMA/NEMA site visits. Nearly \$814,000 was received from FEMA/NEMA from the 2019 disaster; 5.) The surplus equipment was moved to Hartington for the upcoming consignment sale; 6.) Gravel being hauled to County roads; 7.) Discussed getting a larger fuel tank for the Verdigre County Yard; 8) Discussed purchasing a tandem trailer.

At 10:30 a.m., Chairman Sokol, Jr. opened the advertised public hearing for reclassification of a .56-mile portion of Platted Road #732 in Section 19 in Frankfort Township from "Local" classification to "Minimum Maintenance" classification.

Committee update was given the Chairman Sokol, Jr., Supr. Pierce and Supr. Mackeprang who gave a Building and Grounds Committee update.

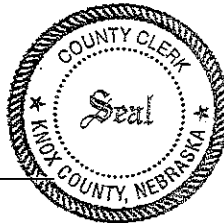
