A regular meeting of the Knox County Board of Supervisors was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, March 5, 2025 at 9:30 a.m. Present were Supervisors Martin J. O'Connor District #1, Kevin G. Mlady District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5 and Danny R. Schlote District #6. Absent was Supervisor James J. Borgmann District #7. Chairman Sokol, Jr. presiding.

County Attorney Knox Jensen led the Board in the Pledge of Allegiance.

Chairman Sokol, Jr. announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Creighton News newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

County Clerk Fischer read the minutes of the February 19, 2025 meeting. Chairman Sokol, Jr. approved the minutes of the February 19, 2025 meeting.

Chairman Sokol, Jr. opened the public comment session at 9:45 a.m.

Correspondence reviewed was: 1.) Dept. of Environment and Energy letter on Mark Miller Livestock Concentrated Animal Feeding Operation NPDES General Permit for Operations Confining Cattle.

Motion by Supr. Schlote, seconded by Supr. Mackeprang that all claims, audited and approved for payment by the Claims Committee, be allowed subject to delinquent personal taxes. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #6. Nays none. Absent was District #7. Motion carried. Claims totaling \$259,662.78 are listed at the end of these proceedings.

Motion by Supr. Mackeprang, seconded by Supr. Pierce to place on file the Clerk of the District Court February 2025 Fee Report. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #6. Nays none. Absent District #7. Motion carried.

Motion by Supr. Pierce, seconded by Supr. Mlady to place on file the Receipts Revenue List of February 17 – 28, 2025. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #6. Nays none. Absent was District #7. Motion carried. Supr. Borgmann arrived at 9:58 a.m.

Chairman Sokol, Jr. closed the public comment session at 9:59 a.m. There was no public comment given.

Chairman Sokol, Jr. moves the Board recess for Board of Equalization at 10:00 a.m.

Hwy. Supt. Barta continued with the following: 3.) Discussion ensued on pickup bids and quotes, new vs. used, state bids and local bids. Motion by Supr. Mackeprang, seconded by Supr. Pierce to authorize Highway Superintendent Kevin Barta to purchase a pickup with a maximum cost of \$39,500. By roll call vote. Ayes all Districts. Nays none. Motion carried; 5.) Topkote in Yankton is closing and the owner is selling equipment privately. There are three used oiling rollers for sale and the Board reviewed pictures and information on the rollers, noting that purchasing one would be to replace the old roller in use since the 1970s. Motion by Supr. Schlote, seconded by Supr. Mlady to purchase a used road roller from Topkote of Yankton SD in the amount of \$30,000. By roll call vote. Ayes all Districts. Nays none. Motion carried; 6.) Reviewed were pictures and information on a truck chassis and utility box to replace the Mechanic's truck. The cost would be approximately \$175,000; 7.) Discussed renting an excavator with mulcher from Jeff Vakoc for trimming trees in County road ditches at a cost of \$300 per hour; 8.) Discussion was held on crack sealing on the Bloomfield South oil road; 9.) Discussed possible bridge projects; 10.) A complaint was received about the Ash Fall intersection. Options to lower the visibility dangers were discussed; 11.) A lot owner adjoining the Center County Yard requested access via the County's driveway as they propose to build a house. County Attorney Knox Jensen said that more information is needed and no action was taken.

Angie O'Connor with Avera met with the Board to discuss the annual on-site wellness program and the 2025 Services Proposal. The basic price will be \$116 per participant this year. Discussion was held on past results and optional testing. Motion by Supr. Mackeprang, seconded by Supr. Borgmann to approve a 2025 On-site Wellness Health Screening of \$116 per participant for full-time Knox County employees as well as spouses who are enrolled in the 90 Degree Benefits health insurance; to allow a \$75 credit per participant towards additional laboratory testing; that those employees participating shall complete a Wellness Questionnaire through the LiveNOW Portal and if the employees and enrolled spouses do not, they are not eligible to participate; that participating members shall meet with Avera staff in a Health Coaching session to review each participant's results of the Wellness Health Screening; to approve reimbursement to those eligible employees and their spouses who are enrolled in the County's health insurance benefit through 90 Degree Benefits/HealthCare Solutions Group and participate in the onsite Wellness Health Screening and complete all of the requirements for the screening with the reimbursement to be up to \$250 of 2025 deductibles paid between \$250 and \$500. Ayes Districts #2, #3, #4, #5, #6 and #7. Abstain District #1. Nays none. Motion carried.

Emergency Manager Taylor met with the Board on the following: 1.) Update on training, meetings, Crisis K-9 Therapy Unit and LEOP; 2.) E.M. Taylor discussed with the Board the purchase of a handheld radio for his use that would allow him to communicate with the Sheriff's Office. Motion by Supr. O'Connor, seconded by Supr. Mackeprang to authorize the purchase of a handheld radio to be purchased using the LATCF grant funds. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Supr. Mackeprang left the meeting at 11:53 a.m.

County Clerk Fischer discussed with the Board the Local Assistance and Tribal Consistency Fund grant. Knox County received \$100,000 through two grant payments and during a discussion after the grant award, it was suggested that the cost of the Flock Safety license plate reader program setup and annual recurring fees be paid from the grant, however, the costs were paid in December 2024 from the Sheriff's function within the General Fund. County Clerk Fischer recommended a journal entry be made crediting the Sheriff's function \$9,450 and transferring the initial Flock Group, Inc. set-up cost of \$9,450 to the Grants function, all within the General Fund. Motion by Supr. Mackeprang, seconded by Supr. Schlote to authorize County Clerk Joann Fischer to make a journal entry transferring the initial Flock Group, Inc. set-up cost of \$9,450 from the Sheriff's function to the Grants function, all within the General Fund, noting the cost will be paid from the LATCF grant funds received in 2022 and 2023. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Motion by Supr. Mackeprang, seconded by Supr. Borgmann to go into closed session at 12:06 p.m. so as to protect the reputation of individuals when discussing personnel. By roll call vote. Ayes all Districts. Nays none. Motion carried. Chairman Sokol, Jr. reiterated the closed session will be held so as to protect the reputation of individuals when discussing personnel. The Board came out of closed session at 12:30 p.m.
