A regular meeting of the Knox County Board of Supervisors was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, March 19, 2025 at 9:30 a.m. Present were Supervisors Martin J. ## **RESOLUTION #2025 - 09**

WHEREAS, the Board of Supervisors deems it is in the public interest to investigate any breaches of security; WHEREAS, the Board of Supervisors, per its Employee Handbook, has the authority to discipline employees for violations of the terms of the Employee Handbook and breach of its Code of Ethics;

WHEREAS, Neb. Rev. Stat. §23-1203 confers authority upon the County of Knox to employ additional counsel in civil matters as it may deem necessary;

WHEREAS, the County of Knox deems it necessary and in its best interests to employ attorney David D. Begley as Special County Attorney to conduct an investigation into possible breaches of courthouse security;

WHEREAS, David D. Begley has decided to associate with attorney Eric M. Hagen as his Deputy Special County Attorney for this matter;

WHEREAS, the Chairman is hereby authorized to enter into an hourly fee agreement with attorneys David D. Begley and Eric M. Hagan for their reasonable compensation with respect to the courthouse security issue;

NOW, THEREFORE, BE IT RESOLVED BY THE KNOX COUNTY BOARD OF SUPERVISORS, that the County of Knox, pursuant to Neb. Rev. Stat. §23-1203, employs attorney David D. Begley as Special County Attorney and Eric M. Hagen as Deputy Special County Attorney to investigate possible breaches of courthouse security.
