A regular meeting of the Knox County Board of Supervisors was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Thursday, April 3, 2025 at 9:30 a.m. Present were Supervisors Martin J. O'Connor District #1, Kevin G. Mlady District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, Danny R. Schlote District #6 and James J. Borgmann District #7. Absent was none. Chairman Sokol, Jr. presiding.

County Sheriff Henery led the Board in the Pledge of Allegiance.

Chairman Sokol, Jr. announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Creighton News newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

County Clerk Fischer read the minutes of the March 19, 2025 meeting. Chairman Sokol, Jr. approved the minutes of the March 19, 2025 meeting.

A request was made to pave or oil a portion of 887 RD between 542 and 543 AVE as there are trucks using this part of the road numerous times during the day. Discussion ensued on costs of grading, paving, oiling or put heavier gravel or rock on that section of road; 5.) Discussed gravel bids accepted at the March 19, 2025 meeting. Samples from three pits were studied as to weight and quality. Discussion continued on not meeting State Spec as bid and options; 6.) At 10:30 A.M., Chairman Sokol, Jr. opened the advertised asphaltic bid opening. Knox County reserves the right to accept or reject any and all bids and further reserves the right to accept bids which are in the County's best interest. One bid was received which was from Jebro Inc., Sloux City IA - MC70 price per gallon - \$4.39; MC250 per gallon - \$4.05; MC3000 price per gallon - \$3.77; CRS-2 price per gallon (estimated gallons 6,000+) delivered to Creighton - \$3.36; Demurrage charge \$160 per hour after one and a half hours, \$100 cancellation fee; \$100 pumping fee each time County requests a pump during placement of orders; returned loads subject to \$400 return fee. Motion by Supr. Schlote, seconded by Supr. Mlady to accept the asphaltic bid from Jebro Inc., Sioux City IA as submitted. By roll call vote. Ayes all Districts. Nays none. Motion carried; 7.) Surveying of the Ash Fall intersection will be done; 8.) Discussed Great Plains placing fiber optic cable in the Crofton area; 9.) Supr. Bill Arnold and NENEDD Business Loan Specialist Jeff Christensen were present. This loan will close the County's Economic Development Fund and all future loans will be under the full direction of NENEDD.
