A regular meeting of the Knox County Board of Supervisors was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, May 14, 2025 at 9:30 a.m. Present were Supervisors Martin J. O'Connor District #1, Kevin G. Milady District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, and James J. Borgmann District #7. Absent was Supervisor Danny R. Schlote District #6. Chairman Sokol, Jr. presiding.

Supr. O'Connor led the Board in the Pledge of Allegiance.

Chairman Sokol, Jr. announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Creighton News newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

County Clerk Fischer read the minutes of the April 30, 2025 meeting. Chairman Sokol, Jr. approved the minutes of the April 30, 2025 meeting.

Chairman Sokol, Jr. opened the public comment session at 9:45 a.m. Commissioner Ed Van Gerpen from Bon Homme County, South Dakota gave public comment regarding wind projects. Also, emailed testimonies on wind energy were submitted by Nest Development LLC, Craig and Rita Wilken and Doug Johnson.

Motion by Supr. Pierce, seconded by Supr. Milady that all claims except Claim #25050125, audited and approved for payment by the Claims Committee, be allowed subject to delinquent personal taxes. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

Motion by Supr. Borgmann, seconded by Supr. Pierce that Claim #25050125 payable to Elder Law and Estate Planning in the amount of \$8,677.71 written from the Inheritance Fund, audited and approved for payment by the Claims Committee be allowed subject to delinquent personal taxes. By roll call vote. Ayes Districts #1, #2, #3, #4 and #7. Nays none. Abstain District #5. Absent was District #6. Motion carried.

RESOLUTION #2025 – 14 – Knox

INTERLOCAL COOPERATION AGREEMENT AND RESOLUTION BETWEEN KNOX COUNTY AND HOLT

COUNTY

1. Knox County and Holt County (together referred to as "Parties") are political subdivisions of the State of Nebraska; and 2. The Interlocal Cooperative Act, Neb. Rev. Stat. §§13-801 to 13-827, permits local governmental units to make the most efficient use of their powers to enable them to cooperate with other governmental units in an effort to provide services and facilities in a manner that will accord with the needs of their local communities; and 3. The parties wish to replace Bridge No. C004539715 (hereinafter "Bridge") on a county line road located on 510 Ave approximately 1.9 miles North 872 Rd on the Knox/Holt County line, and 4. Replacement of the Bridge includes removal and disposal of the superstructure, Northwest Wing, and South Abutment of the existing 16' x 61' timber bridge, purchase and installation of 24' x 65' steel/concrete bridge; and 5. Holt County will use its equipment and personnel to dispose of all materials from the old bridge; and 6. Holt County will pay for the steel products package necessary to rebuild the Bridge that will be purchased from an accepted bidder; and

7. Knox County will use its equipment and personnel to tear out the old bridge and build the new bridge, hours worked on the bridge project will be kept on a spreadsheet for all personnel and equipment used daily. Knox County personnel (including Bridge Foreman and Knox County Highway Superintendent) will charge at a rate of their current hourly wage plus their fringe benefit package (health insurance, retirement, unemployment, worker's compensation, etc.) Knox County will use the rate of 1.5651% for regular time pay per hour and 1.1433% for all overtime pay per hour, which is Knox County's FEMA benefit rate. The following are hourly rates that will be used for use of Knox County equipment (operator not included):

8. The parties agree that Knox and Holt Counties pay equal amounts (50-50) of ALL expenses including, engineering, required drainage study, removal and disposal of the old structure, the purchase and installation of the new structure, wages for Knox County personnel working on replacement of the bridge, hourly rates for use of Knox County equipment in replacing the bridge, and any and all other costs related to the replacement of the bridge; and

9. Each County is responsible for acquiring all required right-of-way or temporary right-of-way easements in their respective county needed to construct the project, if needed; and

10. Sufficient funds of Knox County and Holt County are now, or will be, available and are hereby pledged at the required time for the purpose of paying for said project; and

11. Each County that is a party to this contract agrees to indemnify and hold harmless, protect and defend the other as well as its elected and appointed officials, employees and representatives against any and all claims, demands, suits, actions, payments and judgments, including any and all costs and expenses connected therewith, for the damages asserted, claimed or recovered against the other or its insurers, because of personal injury, including bodily injury or death, or on account of property damage, in any way connected with or resulting from the work associated with this agreement; and

12. Each county shall maintain general liability insurance coverage of not less than \$1,000,000 per occurrence and \$2,000,000 annual aggregate covering personal injury, including bodily injury and property damage involved with this agreement. Each party will carry automobile liability limits of not less than \$1,000,000 single limit. Each party will maintain responsibility for providing its workers with compensation coverage and for any claims associated with its employees.

NOW, THEREFORE BE IT RESOLVED that Knox County and Holt County hereby enter into agreement to replace Bridge No. C004539715 located on 510 Ave approximately 1.9 miles north 872 Road on the Knox/Holt County line. In accordance with the terms listed above.

By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried; 4.) Bridge Crew update; 5.) Oil Crew update.

County Attorney Knox Jensen and Hwy. Supt. Barta discussed the reopening of the West one-half mile of 893 Road (Platted Road #719) located between the SW1/4 of Section 2 and the NW1/4 of Section 11, T32N, R4W (Hill Township). Motion by Supr. Milady, seconded by Supr. O'Connor to adopt Resolution #2025-15 for Knox County's purchase from R & B Husker Valley, LLC the South 33 feet of the SW1/4 of Section 2 and the North 33 feet of the Northwest Quarter of Section 11, all in T32N, R4W of the 6<sup>th</sup> P.M., Knox County, Nebraska being approximately four acres in the amount of \$24,400 and such property shall become a public road again. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

### RESOLUTION #2025 - 15

WHEREAS, the Knox County Board of Supervisors adopted Resolution #2012-06 vacating and abandoning the West one-half mile of 893 Road (Platted Road #719) located between the SW1/4 of Section 2 and the NW1/4 of Section 11, T32N, R4W of the 6<sup>th</sup> P.M., Knox County, Nebraska (being a 66-foot wide right-of-way and approximately 4 acres); and

WHEREAS, such Resolution stated that all title to said vacation and abandonment shall revert to the owners of the abutting real estate, one-half on each side thereof, and become part of such property, as provided by law; and

WHEREAS, R & B Husker Valley, LLC, owned the properties adjacent on both sides of the above-mentioned vacated/abandoned portion of 893 Road (Platted Road #719), and

WHEREAS, the vacated/abandoned portion of 893 Road (Platted Road #719) reverted to R & B Husker Valley, LLC, and

WHEREAS, the Santee Sioux Nation requested that portion of the 893 RD be reopened as it provides access to the Hobo Creek Cemetery as well as access to a parcel owned by the Santee Sioux Nation, and

WHEREAS, the Santee Sioux Nation requested that portion of 893 RD be reopened as the County vacated it without consulting the Santee Sioux Nation, contrary to a Memo of Understanding dated January 1, 2006 between the Santee Sioux Nation, Knox County and the Bureau of Indian Affairs, and



Knox County and that Section 8.08 Commercial/Utility Grade Wind Energy Systems and Section 8.23.05 Commercial Solar Conversion Systems of the Knox County Zoning Regulations be repealed and stricken in their entirety as per the redlined stricken language which had been presented to the Planning Commission by the Zoning Administrator and such hearing to begin immediately following the public hearing that is being held at 1:30 p.m. on the same day and at the same location on the Planning Commission's recommendation for the ban of all new commercial wind and solar developments and to amend the Comprehensive Development Plan as per the redlined stricken language from Chapter 9 of the Comprehensive Development Plan which had been presented to the Planning Commission by the Zoning Administrator. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

Chairman Sokol, Jr. opened at 11:40 a.m. a public hearing for amending Knox County's Community Development Block Grant (CDBG) Economic Development Revolving Loan Fund (RLF). Jeff Christensen, NENEDD Business Loan Specialist, was not able to attend but had presented an explanation of proposed amendment to County Clerk Fischer. Knox County has had a CDBG Economic RLF for many years. The last loan was approved in April 2025 which utilized the remaining funds at the County level which now has zero balance. The Nebraska Department of Economic Development, following directions from Housing and Urban Development (HUD), requested that local RLFs be discontinued and is being done as an amendment to the current RLF guidelines to discontinue the RLF. There are no funds to return to DED.

Brian Eldorado with the Knox County Visitor's Committee presented the recommended 2025 Knox County Visitor's Promotion and Improvement distributions. The approved applicants must present copies of paid receipts to Economic Development Director/Visit Knox County Director Miller before distribution is made. 1.) Motion by Supr. Mackeprang, seconded by Supr. Pierce to approve the following 2025 Knox County Visitor's Promotion distributions noting the amounts to be distributed are contingent on paid receipts that must accompany the entities' invoices: amounts approved – 1.) Winnetoon – Winnetoon BBQ \$500; 2.) Wausa Community Club – Wausa Auto Show, Labor Day, Farmers Market and Christmas in Wausa \$1,000; 3.) Niobrara Promoters – Bridge Days Celebration and Niobrara Alumni \$1,000; 4.) Creighton Area Chamber of Commerce – Creighton Berry Pepper Days \$1,000; 5.) Lewis & Clark SRA – National Martha Day and Dueling Pianos \$1,000; 6.) Niobrara State Park – for purchase of 5 guest-friendly telescopes \$1,400; 7.) Crofton Dam Race \$1,000; 8.) Absent was District #6. Motion carried; 3.) Motion by Supr. Milady, seconded by Supr. O'Connor to approve the following 2025 Knox County Visitor's Improvement distribution to Knox County Development Agency/Visit Knox County – Website updated and tourism branding \$5,328. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

At 11:48 a.m., Chairman Sokol, Jr. closed the public hearing for amending Knox County's CDBG Economic Development Revolving Loan Fund. There was no one present in opposition. Motion by Supr. Borgmann, seconded by Supr. Pierce to approve an amendment to the Knox County Community Development Block Grant (CDBG) Economic Development Revolving Loan Fund (RLF) to discontinue the revolving loan fund. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

Sheriff Henry informed the Board that Department of Justice funds in the amount of \$33,342 were used to pay for new ballistic vests.

Motion by Supr. Borgmann, seconded by Supr. Mackeprang to place on file the Receipts Revenue List of April 28 – May 9, 2025. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

Emergency Manager Taylor met with the Board on the following: 1.) E.M. Taylor has completed all training needed to take the final testing for certification, however, due to the State cancelling testing in April, E.M. Taylor must wait until October to take the certification testing. Discussion was held on E.M. Taylor's wage which is currently \$1,400 per pay period. Motion by Supr. O'Connor, seconded by Supr. Pierce to approve a wage increase for E.M. Taylor to \$1,905 per pay period beginning with the May 4, 2025 pay period noting that no further wage increase will be made until an evaluation is made after the certification testing in October. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried; 2.) With the creation of the Crisis Therapy K9 Program, it was recommended by the County's contracted auditor, Regier Carr & Monroe, LLP, to establish a petty cash checking account to accommodate donated funds and for the expenses of the training, feeding and grooming along with other expenses. Motion by Supr. Mackeprang, seconded by Supr. Milady to adopt **Resolution #2025-16** for establishing a petty cash bank account at the Farmers and Merchants State Bank – Center Branch in the amount of \$50 for the Crisis Therapy K9 Program as per a recommendation by Knox County's contracted auditor, Regier Carr & Monroe, LLP. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

## **RESOLUTION #2025 – 16**

WHEREAS §23-106(2) Nebraska Revised Statute authorizes the County Board to establish a petty cash fund and set the amount of money to be carried in such fund; and

WHEREAS, Emergency Manager Austin Taylor has created a Crisis Therapy K9 Program with the approval of the Knox County Board of Supervisors and wishes to keep the program separate from the tax funded budgets; and

WHEREAS, Knox County's contracted auditor, Regier Carr & Monroe, LLP was contacted and recommended a petty cash checking account be created for such program; and

WHEREAS, the therapy dog which was donated to Knox County and there will be donations and expenses for training, feeding and grooming along with other expenses, and

WHEREAS, many of the Knox County accounts are at the Farmers and Merchants State Bank, Center Branch, and

WHEREAS, Emergency Manager Austin Taylor requests establishment of a petty cash fund in the amount of \$50 for the purpose of having an account for the Crisis Therapy K9 Program so expenses for the program are paid from donations and voluntary service, and

NOW, THEREFORE BE IT RESOLVED, that a petty cash checking account will be established at the Farmers and Merchants State Bank, Center Branch in the amount of \$50 for the Crisis Therapy K9 Program, and

BE IT FURTHER RESOLVED, that the petty cash checking account is being established under the recommendation to Emergency Manager Austin Taylor by the Knox County's contracted auditor, Regier Carr & Monroe, LLP.

Discussion was held on the 2025 Committees and the recent clarification from County Attorney Knox Jensen on the Open Meeting Act regarding appointed advisory committees and subcommittees. The Courthouse and Grounds Committee meets before each Board of Supervisors' meeting, is considered an advisory committee as it is comprised of Board members along with County Clerk Fischer, Senior Office Clerk Rhonda Surface and Custodian Beth Rudloff and the committee must publish a public notice in the legal papers before each committee meeting and minutes must be taken. Subcommittees are not public bodies under the Open Meeting Act so discussion at the Courthouse and Grounds Committee meeting on this date was to change the Courthouse and Grounds Committee from an advisory committee to a subcommittee with the members to be Supervisors Pierce, Mackeprang and Chairman Sokol, Jr. Motion by Supr. Milady, seconded by Supr. Borgmann to change the Courthouse and Grounds Committee from an advisory committee to a subcommittee and the members to be Supr. Pierce, Supr. County Clerk Fischer met with the Board to discuss the legislative changes to County budgets starting in 2025 and future budget preparations. A number of officials recently attended a NACO Budget workshop in York to learn of the major changes that will affect this budget year as well as future budgets due to possible revenue replacements and budget revisions made by the special session of the Nebraska Legislature in the fall of 2024. County Clerk Fischer presented a survey of budget preparers in other Counties and while she has prepared the budget for the last 22 years, she recommends the Knox County 2025/2026 budget be prepared by an accountant or firm to meet the new mandated budget requirements. County Clerk Fischer will present more information at the May 28, 2025 meeting.

Legislative update was held on the ongoing inheritance tax debate by the Nebraska Legislature.

Officials' update was given by County Treasurer Ebel who said that her office collected over \$6.4 million of taxes before the May 1 deadline, noting the taxes collected for all of taxing entities in Knox County.

Motion by Supr. Pierce, seconded by Supr. Mackeprang to go into closed session at 1:19 p.m. to discuss Courthouse security issues. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried. Chairman Sokol, Jr. reiterated the closed session will be held on Courthouse security issues. The Board came out of the closed session at 1:47 p.m.

Motion by Supr. Pierce, seconded by Supr. Borgmann to close at 1:47 p.m. the closed session held on Courthouse security issues. By roll call vote. Ayes Districts #1, #2, #3, #4, #5 and #7. Nays none. Absent was District #6. Motion carried.

Supr. Mackeprang left the meeting at 1:47 p.m.
