Borgmann District #7. Absent was none. Chairman Sokol, Jr. presiding.

Supr. Pierce led the Board in the Pledge of Allegiance.

Chairman Sokol, Jr. announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Hwy. Supt. Barta continued with the following: 3.) Discussed was installing tarps on the County trucks and trailers. It isn't mandatory to tarp the trucks and trailers but Hwy. Supt. Barta said that it may be a good idea. Further discussion was held on rock chips, not all rocks come from the inside of the truck or trailer as there could be rocks on the sides of the box, the number of complaints and the estimated cost at Sioux City Tarp would be \$30,000 to \$32,000.
