PROCEEDINGS OF THE KNOX COUNTY BOARD OF SUPERVISORS

Center, Nebraska July 23, 2025 9:30 a.m.

A regular meeting of the Knox County Board of Supervisors was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, July 23, 2025 at 9:30 a.m. Present were Supervisors Martin J. O'Connor District #1, Kevin G. Mlady District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, Danny R. Schlote District #6 and James J. Borgmann District #7. Absent was none. Chairman Sokol, Jr. presiding.

County Clerk Fischer led the Board in the Pledge of Allegiance.

Chairman Sokol, Jr. announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Crofton Journal newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

County Clerk Fischer read the July 9, 2025 meeting minutes. Chairman Sokol, Jr. approved the minutes of the July 9, 2025 meeting.

Correspondence reviewed was: 1.) Letter from Nebraska Commission on Law Enforcement and Criminal Justice confirming that an annual inspection of the Knox County Jail for the Nebraska Jail Standards Board will be held on July 7, 2025.

The public comment session was opened at 9:45 a.m. Comments were given by Chairman Sokol, Jr. and County Clerk Fischer that due to an oversight, 2024 allocated four holiday dates and the Memorial Day holiday for 2025 were not built into the MIPS Time and Attendance program for seasonal Weed Supt. Banks. The amounts were due, and back pay will be added at the next payroll noting the missed back holiday pay will be at the rate that they should have been had they been originally paid.

Motion by Supr. Schlote, seconded by Supr. Pierce that all claims, audited and approved for payment by the Claims Committee except for Claim #25070216 to Elder Law and Estate Planning, be allowed subject to delinquent personal taxes. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Motion by Supr. Pierce, seconded by Supr. Borgmann that Claim #25070216 payable to Elder Law & Estate Planning in the amount of \$13,143.10 written from the Inheritance Fund, be allowed subject to delinquent personal taxes. By roll call vote. Ayes Districts #1, #2, #3, #4, #6 and #7. Nays none. Abstain District #5. Motion carried.

Claims totaling \$532,237.43 are listed at the end of these proceedings.

The public comment session was closed at 10:08 a.m.

Chairman Sokol, Jr. moves the Board recess at 10:08 a.m. for Board of Equalization.

The Knox County Board of Supervisors reconvened at 10:57 a.m. with all members present.

County Attorney Knox Jensen and Hwy. Supt. Barta discussed with the Board the letter received at a previous meeting from Attorney Ryan Cwach regarding the entrance road into the Kohles Acres Subdivision. The Board reviewed a letter dated July 9, 2025 from Deputy County Attorney John Thomas concerning the 750 ft. stretch of 546 Avenue between Highway 54C and Kohles Acres where the County Attorney's Office has repeatedly suggested an interlocal agreement between SID #1 and Herrick Township would be appropriate to provide funds for this road. Suggested in the July 9, 2025 letter was that the Board consider proposing an interlocal agreement for the stretch of 546 Avenue that SID #1 pay 50% of the costs of the road and maintenance, that Herrick Township pay 50% of the costs of the road and maintenance, and that the County perform such costs and maintenance and bill this to the SID #1 and Herrick Township semi-annually. The Board discussed companies that could grind the entrance road and do maintenance. Motion by Supr. Mlady, seconded by Supr. O'Connor to decline the suggestion by Deputy County Attorney Thomas that the County provide the costs and maintenance of the Kohles Acres entrance road as an interlocal agreement should be made between the SID #1 and Herrick Township for the costs and maintenance of the 750 ft stretch of 546 Avenue between Highway 54C and Kohles Acres as the entrance road is not a County road and that they hire other construction companies to grind the entrance road and provide the costs and maintenance. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Hwy. Supt. Barta met with the Board on the following: 1.) The County shop inventories were handed out to the respective Supervisors for their review and signatures; 2.) The Board reviewed two alternative plans from Mainelli Wagner & Associates for construction of the Ashfall road intersection. Alternative 1 was in the amount of \$306,196 and Alternative 2 was in the amount of \$267,400. Hwy. Supt. Barta believes the County can do the work at a lower rate. More discussion will be held at a later date; 3.) Discussed was the Lost Creek bridge listed on the Santee Sioux Nation/BIA Tribal Transportation Facility Bridge Program. Hwy. Supt. Barta will research the bidding process for construction; 4.) Bridge Crew update; 5.) Oil Crew update; 6.) The Board had considered at the last meeting the NDOT Highway 12 East and West agreement and resolution and Hwy. Supt. Barta was directed to contact the NDOT regarding the costs of signage of detour routes. The State will not pay for the detour signage so the County will be responsible. Motion by Supr. Mackeprang, seconded by Supr. Borgmann to adopt Resolution #2025 – 23 approving the execution of an agreement between the Department of Transportation of the State of Nebraska for Project No. S-12-5(1011), Control No. 31674, Agreement No. XL2508, project name Niobrara East and West County Road Connections and the authorization of Chairman Sokol, Jr. to sign such agreement. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Pierce, seconded by Supr. Borgmann to place on file the Planning Commission's Report to Board of Supervisors on Conditional Use Permit #CU2501 submitted by 3A LLC. By roll call vote. Ayes all Districts. Nays none. Motion carried; 3.) A recent Zoom meeting was held on the Weigand Marina project. The project has been scaled back to 257 slips and no buildings or dirt work; 4.) Motion by Supr. Pierce, seconded by Supr. Mackeprang to go into closed session at 11:35 a.m. as per the request of Zoning Administrator Jelinek for the discussion of personnel. By roll call vote. Ayes all Districts. Nays none. Motion carried. Chairman Sokol, Jr. reiterated the closed session will be held as per the request of Zoning Administrator Jelinek for the discussion of personnel. Also present during a portion of the closed session was County Clerk Fischer. The Board came out of closed session at 12:15 p.m.

The Board discussed the wage for Zoning Administrator Jelinek. Originally Zoning Administrator Jelinek had been hired as both Emergency Manager and Zoning Administrator, however, the positions were changed to stand alone positions in December 2024 when Austin Taylor was hired as the Emergency Manager. The Zoning Administrator position is not an exempt position, so is now an hourly position. Motion by Supr. Mlady, seconded by Supr. Mackeprang to set Zoning Administrator Jelinek's wage at \$27.00 per hour, noting that amount includes a 5% increase, starting with the July 13, 2025 pay period. By roll call vote. Ayes Districts #1, #2, 3, #4, #5 and #7. Nays District #6. Motion carried.

Motion by Supr. Mackeprang, seconded by Supr. Schlote, as pursuant to Revised Statute Section 23-122, employee salaries as of July 2025, be published in the legal papers of the Creighton News and Crofton Journal by August 15, 2025. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Pursuant to Section 23-122, Reissue Revised Statutes of Nebraska, salaries & job descriptions of County officials and employees are required to be published between July 15 and August 15. Benefits include a single dental/vision policy, a \$15,000 life insurance policy, and eligible employees receive a single health insurance policy. In addition, eligible employees can enroll their spouses, child(ren), or family in the County health insurance with Knox County paying the premium for the spouse/child(ren)/family health insurance coverage. In lieu of health insurance, eligible employees receive a taxable \$183/pay period stipend for opting out of County health insurance coverage. Those not receiving insurance will be marked "no insurance." Non-exempt employees' salaries are based on an eight-hour workday with exception of law enforcement and non-exempt employees are eligible for overtime pay for hours worked over 40 hours a week at one & one-half times hourly rate. WHEREAS, the 911 Wireless Service Holding Fund, with combined Legacy and NG911 funds, held a balance of \$36,372.48 as of June 30, 2025, and

WHEREAS, of the \$36,372.48 in the 911 Wireless Service Holding Fund, \$20,372.48 is Legacy funds remaining and shall be depleted by March 31, 2026, in accordance with the pay down mandate by the Nebraska Public Service Commission, and

WHEREAS, the remaining NG911 balance, and any further NG911 fund allocated to this account, may be set aside with no depletion deadline nor approval needed by the Nebraska Public Service Commission, for funding current or future eligible expenses related to 911, and

NOW, THEREFORE BE IT RESOLVED by the Knox County Board of Supervisors approve the <u>transfer through</u> the claims process of \$25,000.00 of NG911 funds from the 911 Wireless Service Fund to the 911 Wireless Service Holding Fund during the 2025/2026 Fiscal Year.
