

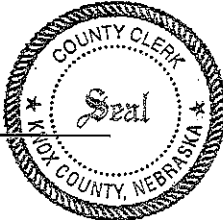
Public comment session was held at 10:15 a.m. No one gave public comment.


