

PROCEEDINGS OF THE KNOX COUNTY BOARD OF EQUALIZATION

A regular meeting of the Knox County Board of Equalization was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, June 11, 2025 at 10:01 a.m. Present were Supervisors Kevin G. Mlady District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, Danny R. Schlote District #6 and James J. Borgmann District #7. Absent was Supervisor Martin J. O'Connor District #1. Chairman Schlote presiding.

Chairman Schlote announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Creighton News newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

County Clerk Fischer read the May 28, 2025 meeting minutes. Chairman Schlote approved the minutes of the May 28, 2025 meeting.

County Assessor Beckmann met with the Board on the following: 1.) Motion by Supr. Sokol, Jr., seconded by Supr. Mlady to place on file the Certificate of Completion of Assessment Roll for Knox County dated May 30, 2025. By roll call vote. Ayes Districts #2, #3, #4, #5, #6 and #7. Nays none. Absent was District #1. Motion carried; 2.) Review of the June 1, 2025 report of Omitted/Over/Under changes. Motion by Supr. Mackeprang, seconded by Supr. Pierce to place on file the Omitted/Over/Under Report dated June 1, 2025. By roll call vote. Ayes Districts #2, #3, #4, #5, #6 and #7. Nays none. Absent was District #1. Motion carried; 3.) Motion by Supr. Sokol, Jr., seconded by Supr. Mlady to approve Tax List Correction #8022 Burns Lumber Company as business is being sold so accelerated personal property using the 2024 levy. By roll call vote. Ayes Districts #2, #3, #4, #5, #6 and #7. Nays none. Absent was District #1. Motion carried; 4.) Several people have called regarding their valuation changes.

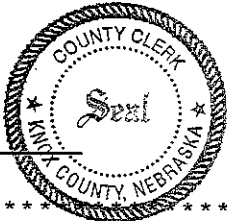
The public comment session was held at 10:11 a.m. No one gave public comments.
