

PROCEEDINGS OF THE KNOX COUNTY BOARD OF EQUALIZATION

A regular meeting of the Knox County Board of Equalization was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, August 6, 2025 at 10:06 a.m. Present were Supervisors Kevin G. Mlady District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, Danny R. Schlote District #6 and James J. Borgmann District #7. Absent was Supr. Martin J. O'Connor District #1. Chairman Schlote presiding.

Chairman Schlote announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Creighton News newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

County Clerk Fischer read the July 23, 2025 meeting minutes. Chairman Schlote approved the minutes of the July 23, 2025 meeting.

Motion by Supr. Sokol, Jr., seconded by Supr. Mlady to approve an additional wage of \$10 per day for the Assessor's staff who go out and do property reviews. By roll call vote. Ayes Districts #2, #3, #4, #5, #6 and #7. Nays none. Absent was District #1. Motion carried.

Motion by Supr. Borgmann, seconded by Supr. Sokol, Jr. to approve Form 457 Application for Exemption from Motor Vehicle Taxes by Qualifying Organizations being St. Ludger Catholic Church on a 2002 Chrysler Town Country van. By roll call vote. Ayes Districts #2, #3, #4, #5, #6 and #7. Nays none. Absent was District #1. Motion carried.



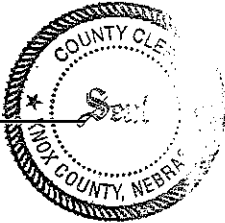
The public comment session was held at 10:10 a.m. No one gave public comments.
