INSTRUCTIONS TO VOTER

The following are instructions on how to vote your ballot. Please follow these instructions precisely, otherwise, your ballot may not be counted.

1. Verify that there are the initials or signature of an election official at the bottom of the ballot.
2. Verify that there are no voting marks on the ballot.
3. Use a black ink pen to mark the ballot.
4. **TO VOTE, you must darken the oval completely (●)** next to either "FOR such Bonds and tax" or "AGAINST such Bonds and tax".
5. Do NOT cross out or erase. If you make a mistake, write "Void" across the face of the ballot and contact the Knox County Clerk for instructions at (402)-288-5604.
6. Place voted ballot into the brown Return Identification Envelope. Write your NE driver's license or state ID in the space provided on the envelope, or enclose a photocopy of an acceptable photo ID or Reasonable Impediment Certification (if applicable). Complete, SIGN and seal the envelope. Remember to moisten both seals to cover the voter ID and signature boxes.
7. Any voter physically unable to sign the envelope must make his/her "mark" and must have an individual witness. Failure to complete and sign the brown Return Identification Envelope will cause the ballot to be rejected.
8. **DO NOT PLACE MORE THAN ONE VOTED BALLOT IN THE BROWN RETURN IDENTIFICATION ENVELOPE.**
9. Return Ballot by:
  - a. Hand Delivery - deliver the ballot to the office of the Knox County Clerk - 206 Main Street, Center, NE
  - b. Mail - return ballot by mail by placing proper return postage on the envelope. Voter must affix 78 cents postage to brown Return Identification Envelope.
  - c. Drop Box Location - East Foyer of the Knox County Courthouse
10. Ballot MUST be in the possession of the Knox County Clerk's Office by 5:00 p.m. Central Time on November 4, 2025

School Bond Election

In the State of Nebraska

"Shall Knox County School District 0576 (Wausa Public Schools) in the State of Nebraska (the "District") issue general obligation bonds of the District in an aggregate stated principal amount not to exceed Two Million One Hundred Fifty Thousand Dollars (\$2,150,000), for the purpose of providing funds to pay the costs preparing, constructing and equipping improvements to the District's existing property and facilities, which may include, without limitation, installation of a new 8 lane track, improvements to bleachers and other components of the District's track and field facilities, and related improvements, and providing for the necessary furnishings, equipment and apparatus for such facilities; such bonds to be issued from time to time, to bear interest at such rate or rates, to be sold at such prices and to become due at such time or times as may be fixed by, or determined at the direction of, the Board of Education; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"
