A regular meeting of the Knox County Board of Equalization was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of Wednesday, March 18, 2026 at 10:05 a.m. Present were Supervisors Martin J. O'Connor District #1, Kevin G. Mlady District #2, David L. Pierce District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, Danny R. Schlote District #6 and James J. Borgmann District #7. Absent was none. Chairman Schlote presiding.

Chairman Schlote announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Wausa Gazette newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereinafter shown were taken during the convened meeting that was opened to the attendance of the public.

County Clerk Fischer read the March 4, 2026 meeting minutes. Chairman Schlote approved the minutes of the March 4, 2026 meeting.

Motion by Supr. Borgmann, seconded by Supr. Sokol, Jr. to approve a Notice of Reduction/rejection of Homestead Exemption Form 458R. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Motion by Supr. Pierce, seconded by Supr. Sokol, Jr. to approve Tax List Correction #8041 Michael F. and Amy B. Pickinpaugh where applicant and spouse no longer want to claim exemption and want to pay the taxes – reversed 2025 homestead from 100% to 0%. By roll call vote. Ayes all Districts. Nays none. Motion carried.


County Assessor Beckmann informed the Board that she had sent in the abstract noting that she had received confirmation that it balanced and now the State will review it.

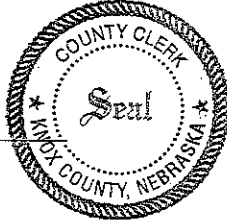
The public comment session was held at 10:08 a.m. No one gave public comment.


